

**Memorandum of Understanding**

This Memorandum of Understanding (“MoU”) is made and executed on 21<sup>st</sup> day of April’ 2020 (“Effective Date”), by and between **JAYPEE HEALTHCARE LIMITED**, a company incorporated and existing under the Companies Act, 1956 and having its registered office at Sector-128, Noida, 201 301(“JHCL”) and **NOIDA CHAPTER OF NIRC OF THE INSTITUTE OF COMPANY SECRETARIES OF INDIA, a Chapter of THE INSTITUTE OF COMPANY SECRETARIES OF INDIA, which is a statutory professional body enacted under the act of parliament, and having its principal place of service at C-37, Sector-62, Noida, Gautam Buddh Nagar, Uttar Pradesh,201301 (“NOIDA CHAPTER OF NIRC OF ICSI”)**

*JHCL and NOIDA CHAPTER OF NIRC OF ICSI shall be collectively referred as “Parties” and individually as “Party”.*

**WHEREAS, JHCL** owns and operates a world-class super specialty hospital at Sector 128, Noida, Uttar Pradesh- 201 304 under the brand name "Jaypee Hospital" and **NOIDA CHAPTER OF NIRC OF ICSI, a Chapter of ICSI** (ICSI is the only recognized professional body in India to develop and regulate the profession of Company Secretaries in India). **NOIDA CHAPTER OF NIRC OF ICSI** desires that employees (“Employees”), members (“Members”) and students (“Students”) of ICSI along with their dependants (“Dependants”) be allowed to avail the In Patient Department (“IPD”), Out Patient Department (“OPD”) and Preventive health check-up services listed in **ANNEXURE A** hereto provided at Jaypee Hospital on a discounted rate (“Services”). **JHCL** has agreed to offer the Services to the Employees, Members, Students and their Dependants, of the **THE INSTITUTE OF COMPANY SECRETARIES OF INDIA (ICSI)** on the terms and conditions as set out herein.

**NOW, THEREFORE:**

**1. OFFER AND PROCEDURE TO AVAIL THE OFFER**

- a. **NOIDA CHAPTER OF NIRC OF ICSI** desires that the Employees, Members, Students and their Dependants may be entitled to avail the Services at Jaypee Hospital at a discount on Jaypee Hospital's prevailing rates (“Discount”). The said Discount shall be applicable as per the rates listed in **ANNEXURE A**.
- b. The said Discount shall be available on furnishing the following documents and payment of **cash/ credit or debit card** by Employees/ Members/ Students and Dependants directly to **JHCL**:

In case the Employee/Member/Student//Dependant is covered by any insurance policy, he/she should furnish the card of the TPA/Insurance Company and provision of Services to such Employee /Member/Student/ /Dependant shall be guided as per **JHCL's** existing terms and conditions with such TPA/Insurance Company.

- c. The Discount shall be available subject to the following conditions:
- Discount shall be available upon furnishing the documents set out in Clause 1(b) above. Employees/Member/Student//Dependants must furnish copies of said documents for **JHCL's** records and carry them at all times during availing the Services. **JHCL** shall reserve the right to refuse the Discount to any Employees/Members/Students/ /Dependants in case requisite documents are not furnished.
  - Discount cannot be clubbed with any other scheme/ discount/ offer made available by Jaypee Hospital from time to time.
  - Discount under this MoU cannot exceed the rates set out in **ANNEXURE A** and cannot be availed on the exclusion in the Services as listed in **ANNEXURE A**.
  - Discount can only be availed at Jaypee Hospital and at no other facility owned or operated by **JHCL**.
  - Discount shall not be available on applicable taxes, if any, which shall be charged extra.
  - Discount can be availed only during the validity of this MoU.
- d. In case of emergency, where the Employee/ Members/ Students/ and/or the Dependent is unable to procure or furnish the documents required as per Clause 1(b) above at the time of admission, Discount as per **ANNEXURE A** can be availed, provided, the aforementioned documents are furnished by the next working day or prior to the discharge of the Employee/Member/Student/ /Dependant.
- e. Details of various preventive health check-up packages available at Jaypee Hospital are detailed hereinafter as **ANNEXURE B**.
- f. **JHCL** reserves the right to revise the rates of the Services from time to time. Upon such revision, Discount shall be applicable on then current **JHCL's** rates for Services, subject to the intimation to NOIDA CHAPTER OF NIRC of ICSI.

2. No Party shall use the proprietary marks i.e. trade name, logo or any other intellectual property of the other Party for any purpose whatsoever; except for promotional and marketing activities as mutually agreed in writing.
3. This MoU shall be valid unless otherwise terminated in accordance with Clause 5 (“Term”).
4. Either Party may terminate this MoU by giving 30 (thirty) days prior written notice to the other Party without assigning any reason for the same.
5. This MoU shall be governed by the laws of India. Any dispute which is not resolved through amicable settlement within 30 (thirty) days from the date of receipt of a written notice from one Party to another, such dispute shall be resolved by a sole arbitrator appointed mutually by both Parties. Subject to aforementioned, this MoU shall be subject to the exclusive jurisdiction of the competent Courts of Uttar Pradesh.
6. Any notice hereunder shall be effective only if it is in writing and shall be deemed received (i) upon delivery when delivered by hand, (ii) 3 (three) days after being sent, if sent with all sending expenses prepaid, by an express courier, (iii) when transmitted, if sent by confirmed facsimile, or (iv) 7(seven) days after being sent, if sent by registered mail, to the address set out in the head of the MoU.
